

Radio & TV Announcement: PORTGE CO BD OF MR/DD CLOSED

The entire program is **CLOSED** including Happy Day School, Portage Industries, and the Dennis M. Coble Administration Building. No Board Transportation Services operating.

Radio & TV Announcement: PORTAGE CO BD OF MR/DD PLAN A

Happy Day School, Portage Industries, and the Dennis M. Coble Administration Building are **OPEN**.

Board transportation services WILL NOT operate in the northern portion of the county (anyone living NORTH of the Ohio Turnpike).

Board Transportation Services WILL operate in all other portions of the county

Radio & TV Announcement: PORTAGE CO BD OF MR/DD PLAN B

Happy Day School, Portage Industries, and the Dennis M. Coble Administration Building are **OPEN**.

Board transportation services WILL NOT operate in the southern portion of the county (anyone living SOUTH of Interstate 76).

Board Transportation Services WILL operate in all other portions of the county

Please note that under both the **PLAN A** and **PLAN B** announcements, Happy Day School, Portage Industries, and the Dennis M. Coble Administration Building are **OPEN** but depending upon whether you are affected by **PLAN A** or **PLAN B**, Board transportation will not be provided. Even though Board transportation will not be provided, you as a parent, guardian, or provider can transport someone to/from Happy Day School or Portage Industries on a either a **PLAN A** or **PLAN B** day.

The **PLAN A** and **PLAN B** announcements **DO NOT** affect transportation services to/from Portage Industries provided by PARTA or Family & Community Services (FCS). PARTA and FCS will continue to provide scheduled transportation, although with possible delays, on both **PLAN A and PLAN B** days. Even though PARTA and FCS will be providing transportation on PLAN A and PLAN B days, you may certainly choose to not have PARTA or FCS transport on that day. PARTA and FCS will not provide scheduled transportation services to Portage Industries with a **CLOSED** announcement.
